

Section 1- Frequently Asked Questions with No Show, Delay and Cancellation Flat Fee Rate.

1) What does a Shared-Ride mean? A "Shared-Ride" means that a guest may share a van or 4 door sedan ride to the airport, train terminal, bus stations or points of interest with other guests having the same time or a similar traveling arrangement which reduces the fares. HLR does offer a "private van or 4-door sedan" airport service for an individual or small group of 1-4 people without "sharing" the travel ride for a nominal fee. (See Section 4 & 5 rate sheets)

2) Why does HLR charge a No Show, Delay and or Cancellation fees?

HLR understand that flight delays, emergencies and cancellations occur but because of airplane mechanical failures, miss connections, weather related matters and other acts of God beyond our control, schedules have been arranged so HLR must charge a flat fee when a guest does not "show up" or has not contacted the HLR dispatcher with their flight delays or cancellation information within 1 hour of a "scheduled shuttle pickup."

- a) The "No Show, Delay and Cancellation Flat Fee Charge is: \$35.00. No Exceptions! The HLR 24 hours dispatch voice service mailbox (410-777-5266) is always on.**

3) What is HLR'S Baggage Policy?

HLR follows the same baggage policy outlined by the airlines. Domestic flights within the United States are allowed 1checked bag, 1 carry-on and International Flights are allowed 2 checked bags, 1 carry-on. Luggage cannot exceed 50 pounds per checked bag. All oversized/extra items such as pet carriers, skis, surfboards, musical instruments, golf clubs and or trade show displays will be charged additional fees. (See Section 8 for oversized/extra item fees). Please call HLR (410-777-5266/ 410-988-3868) to make special arrangements before your trip.

HLR Courier and Shuttle, LLC. provides a van or a 4 door Sedan shuttle service to Washington, D.C. metropolitan points of interest and Reagan National and Dulles International Airports. Shuttle transportation service is offered to train, local tourist attractions, local shopping trips and bus stations while travelling to or from Northern Virginia to Prince Georges County, Montgomery County and Washington, D.C.
