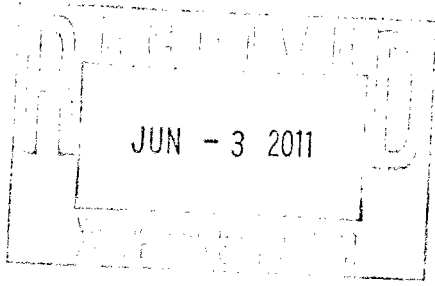

RULES AND REGULATIONS:

A. CLEANING CHARGE

If, in the opinion of Carrier, any passenger or passengers so foul(s) the vehicle as to render it to be In a particularly dirty condition a cleaning charge of \$150.00 will be charged against that passenger or passengers.

B. DAMAGE CHARGE

Vehicles are carefully inspected by Carrier prior to each trip. Any damage to seats, windows, or other equipment or parts of the vehicle which is caused by any passenger(s) shall be the responsibility of the passenger(s) and the cost to Carrier for repairs of such damage shall be paid by the passenger(s).

C. TOLLS, FEES AND SPECIAL CHARGES

The charges herein do not include bridge, ferry, tunnel or highway tolls, entrance fees or charges for special licenses or permits. An additional charge will be assessed for the cost of any such tolls, fees or special charges.

D. APPLICATION AND COLLECTION OF CHARGES

All rates and charges for transportation services are payable in advance, unless credit is established with Carrier, in the lawful currency of the United States of America

There will be a minimum of three (3) hours at \$85.00 a hour.

Cancellations must be received 48 hours prior to the trip. Otherwise passengers will be charged for three hours.

Carrier reserves the right to select the route and/or highways to be used in all transportation services.

E. **LIABILITY**

Carrier does not guarantee to arrive or depart from any point at a specified time, but will endeavor to maintain the schedule submitted by its Agent or employee.

If any Act of God, public enemies, authority of law, quarantine, perils of navigation, riots, strikes, the hazards or dangers incident to a state of war, accidents, breakdowns, bad conditions of the road, storms or other conditions beyond its control, make it, in the opinion of the Carrier inadvisable to conduct operations, Carrier shall not be liable therefore.
