Sedan Class Rates:

- Sedan Class vehicles with maximum capacity of six passengers including driver.
- Rates does not include gratuity, tolls, or parking fees.

(A) Hourly rate:

An hourly rate of \$65.00 will be charged for travel within Washington Metropolitan Area Transit District as defined by Washington Metropolitan Area Transit Commission. Two hours is the minimum rental for a chauffeured sedan.

(B) Transfer Rate:

Transfer rate will be charges for any non-stop one way trips within Washington Metropolitan Area Transit District as defined by Washington Metropolitan Area Transit Commission. Two seperate rates apply for sedan transfer:

1- Short Transfer Rate \$65.00

Short transfer rate will be charges for any trips originating from and terminating at points inside the Capital Beltway.

2- Long Transfer Rate \$115.00:

Long Transfer Rate will be charged for any trips originating from points inside the Capital Beltway and terminating at points outside the Capital Beltway and vise versa.
