



### RULES REGULATIONS

#### A) Objectionable Persons

a) Carrier reserves the right to refuse to transport person(s) i) under the influence of intoxicating liquor or drugs: incapable of taking care of himself or herself.

#### B) Cleaning Charge

a) If, based on Carrier's opinion, any passenger(s) foul(s) the vehicle as to render it to be in Particular dirty condition, a cleaning charge of \$100.00 will be charged against the passenger(s).

#### Damage Charge

a) Vehicle is checked by Carrier prior to each trip.

b) The passenger is responsible for any damage caused by the passenger.

**E) Tolls, Fees and Special Charges**

a) The charges herein do not include bridge, ferry, tunnel or highway tolls entrances fees or charges special licenses or permits.

**F) Liability**

a) Carrier does not guarantee to arrive or depart from any point at a specified time, but will to maintain schedule. Exceptions Carrier liability: other conditions beyond carrier control make, in carrier's opinion, inadvisable to conduct operations.

**Payment and Cancellation Charges and Fees**

a) All charges fees shall be the responsibility of the person customer booking the Trip. Carrier reserves the right to collect payment in advance.

b) If the trip is cancelled within 48 hours of the scheduled departure time by the Passenger, the passenger forfeits its advance deposit as a penalty.
