



C. OTHER CHARGES:


C.1- Cleaning Charges: if, in the carrier reasonable opinion, any passenger (s) soils the vehicle as to render it in an unpresentable condition for further use, a cleaning charge of \$100 will assessed against the passenger (s).

C.2- Damage Charge: vehicles are carefully inspected by carrier prior to each trip. Any damage to seats, windows, or any other parts of the vehicle, which is caused by the passenger (s) shall be the responsibility of that passenger (s). The costs for the repairs of such damages shall be paid by the passenger (s).



C.3- Tolls, Fees, and Special Charges: the charges do not include parking, bridge, ferry, tunnel, or highway tolls, entrance fees or charges for special licenses or permits. An additional charge will be assessed for the cost of such tolls, fees, or special damages.
