Terms & Condition

Cancelation policy:

For Sedan Or SUV: If you choose to cancel your reservation, we require that you do so at least 3 hours in advance, otherwise you will be charged for the full amount of your trip.

The chauffeur inspects each vehicle before, during and after each rental. In the event of any damages suffered to our vehicle; the customer assumes responsibility for the cost of cleaning and repair.

Waiting Time:

For pick-ups Originating at points other than airports, there is a "15 minutes" grace period. After that time, there is a charge for every quarter of an hour based on the hourly rate.

At all airports:

A 30 minutes grace period is allowed following the reported Domestic flight arrival time.

An hour grace period is allowed following the reported international flight arrival time.

A fee for every quarter of an hour based on the hourly rate will be charged after the grace period has elapsed.

Gate Meet: \$15.00

Extra Stops:

Extra Stops are charged a \$25.00 fee. If the stop requires waiting longer than 5 minutes, a "wait-time" fee for every quarter of an hour will be charged.

Other:

-Parking fee: Will be Added

-Toll Fee: Will be added

-Airport Toll fee of \$5.00 for DCA & IAD will be added to the airport rates for Sedan & SUV trips.

-In the event that you need to schedule a late pick-up (in the hours between Midnight and 5:30 am, you will be charged an extra \$25).
