damage to seats, windows, or others equipment or parts of the vehicle which is caused by any passenger or passengers shall be the responsibility of that passenger or passengers and the costs to carrier for the repairs of such damages shall be paid by the passenger(s).

c) **Tolls, fee and special charge:** the charge herein do not include parking, bridge, ferry, tunnel or highway tolls, entrance fees or charges for special licenses or permits. An additional charge will be assessed for the actual cost of such tolls, fees or special charges.

d) **CHANGES EN ROUTE:** If changes en route from the original movement are ordered by the party chartering the vehicle, any additional mileage resulting therefrom will be computed upon the charges set forth herein.
