3. SEDAN TRANSFERS RATE:

Local transfers in metropolitan area are \$35.00 per transfer for 5 miles or less, plus \$3.50 for each additional mile.

4. CANCELLATION, NO-SHOW AND ORDER MODIFICATION RULES:

To avoid cancellation charges, orders must be cancelled two hours before reservation time. A no-show will be charged after 30 minutes and cancellation charges will apply. No-shows and cancellation charges will be charged 100% of the reservation total.

5. **AIRPORT PICKUP PRICING AND PROCEDURES:**

Ride in Style drivers will meet passengers inside the Arrival terminal, unless otherwise instructed. In this case parking charges will apply. To avoid parking charges, passengers can request an outside pickup. Customer will also be charged for toll road charges, related to the service provided.

6. **Additional Transfer Charges:**

Rush hour surcharge – additional \$10.00 on each transfer that occurs during the following hours (except Saturday and Sunday):

7:30 am to 9:30 am.

4:00 pm to 6:30 pm.

7. **Charge for prearranged stops in middle of service:**

Each prearranged stop is an additional \$10.00 charge (does not include waiting time)

8. **Charge for prearranged waiting time in middle of service:**

Each minute of time spent waiting at a prearranged stop is an additional \$1.00.

9. **Additional Transfer and Hourly Charges:**

Additional 20% gratuity is added to total charges, at the end of the service, added to all customers.
