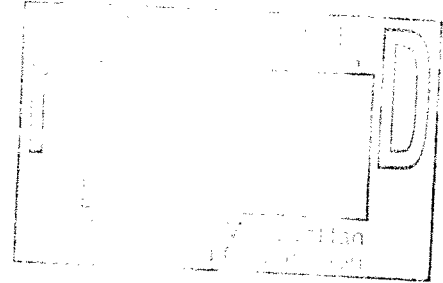

C.2- Damage Charge: vehicles are carefully inspected by carrier prior to each trip. Any damage to seats, windows, or

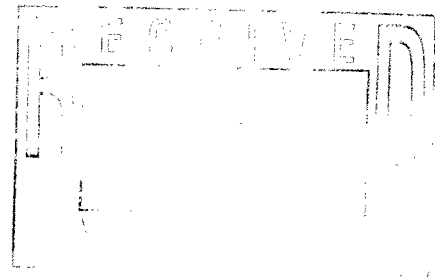
