Hourly Charges:

All hourly charges are for a 6 passenger Luxury SUV.

Hourly Rates: \$69 per hour with a 2 hour minimum charge.

Parking and Toll fees are additional.

A 20% surcharge will be added for services between the hours of 12am and 5am.

Time is to be calculated from the time the vehicle leave's the carrier's place of business at the beginning of the charter trip until it returns to the carrier's place of business at the conclusion of the charter trip.

A 20% driver gratuity will be added to the charges shown above.

The vehicle will make stops en route at the request of the passenger(s). An additional charge of \$1.00 per minute will apply for stops.

A no show charge equal to the trip cost , a waiting time charge and an additional 20% service fee will be charged to the passenger that fails to show at the designated pick up location.

A cancellation charge equal to the trip cost will be charged for any cancellation made less than 2 hours before the scheduled pick up time.

Wait time charges applied in 15 minute increments at \$1.00 per minute after grace period.

A \$10 Meet and Greet fee shall apply for all airport pickups that require parking.

All charges shall be calculated and paid in US currency by cash and major credit cards.

Vehicles offered for service are carefully inspected by the carrier prior to assignment to such Service. Any damage to the exterior or interior of the vehicle which is inflicted by any member of the chartering party shall be the responsibility of the chartering party and the costs to the carrier for the repair of such damage shall be paid by the chartering party.

A cleaning fee for damage to the interior or the cost of parts and labor cost to repair/replace interior components caused by vomiting,sickness,spills,behavior or accident will be assessed and charged to the client when applicable, a \$250 fee for professional cleaning and detail.
