Mr. Jorge Eduardo Mesquita offers distinctive transportation service to the public. Our rates are determined by either the pick up and drop-off location or by the hour. The rate is a blend of two rates, where stops are scheduled between pickup and drop-off, determined in accordance with the rules of this tariff. The total service price includes a gratuity fee and customer select options. The following sections state the tariff for the services offered by Mr Jorge Eduardo Mesquita.

1. POINT TO POINT RATES:

Point to Point Rates are derived from the chart below.

From/To	DCA /Reagan	IAD/Dulles
Washington DC	U\$ 75,00	U\$ 100,00
Chevy Chase MD	U\$ 85,00	U\$ 115,00
Bethesda MD	U\$ 95,00	U\$ 120,00

Some point to point services could be added on these rates as follows:

.Gratuity of 20% as a tip for the driver

.Cleaning Fee if passenger(s) soils the vehicle as to render it in an unpresentable condition for further use. The cleaning fee added will be U\$ 100,00

.Damage to any part of the vehicle caused by the passenger(s) and the cost for the repairs of such damages shall be paid by the passenger(s).

.Optional services such Stops, Waiting Time, Tolls, Parking and Off Peak Charge will be assed to the rates as follows:

Stops en Route.....U\$ 15,00 per stop

Waiting Time.....U\$ 75,00 per hour in quarter-hour increments

Off Peak.....U\$ 20,00 Off peak charge will be assed between 12 am to 5 am.

TollsPassengers responsible for any charges during the trip.

Parking....Passengers responsible for any charges during the trip.

2. HOURLY RATE SERVICES:

Base Rate.....U\$ 85,00 per hour with minimum of 4 hours.

All the services charges associates with the Point to Point services will be also added in the Hourly Rates

3. CANCELLATION, NO SHOWS AND ORDER MODIFICATION RULES:


To avoid cancellation charges, orders must be cancelled two hours before reservation time. A No Show and Cancellation Fee will be charged 100% of the reservation total.

4. AIRPORT PICK UP PRICING AND PROCEDURES:

All pick ups at the airports will be done inside the Arrivals Gate or Baggage Claim Areas, unless otherwise instructed. In this case, parking charges will apply. To avoid parking charges, passenger(s) can request an outside pick up.
