## **Ambulatory**

- Ambulatory rates are as follows: \$ 55.00 one way or \$85.00 round trip
- Weekend/Holiday/After 6PM Ambulatory rates are as follows: \$105.00 one way or \$135.00 round trip

## **Wheelchair**

- Wheelchair rates are as follows: \$135.00 one way or \$ 195.00 round trip
- Weekend/Holiday/After 6PM Wheelchair rates are as follows: \$185.00 one way or \$245.00 round trip

\*Wait times are charged in 15 minute intervals with 45 minutes being the maximum time given per client appointment. That fee will be charged at \$20.00 per 15 minute wait interval.

\*A cancellation fee will be charged to the client at a flat rate of \$45.00. A cancellation must be called in 3 hours before scheduled pick up time.

\*Any passenger route that exceeds more than 15 miles in any one direction, whether pick up or drop off will incur an additional service charge at \$1.75 per mile.
