3- Other Charges:

A) Cleaning Charge: if in the carrier's reasonable opinion, any passenger soils the vehicle as render it in an unpreventable condition for further use, a cleaning charge of \$180 will be assessed against that passenger(s).

C) Tolls, fee and special charges: the charge herein doesn't include parking, bridge, ferry, tunnel or highway tolls, entrance fees or charges for special licenses or permits. An additional charge will be assessed for the actual cost of such tolls, fees or special charges.

D) Changes on route: If changes on route from the original movement are ordered by the party chartering the vehicle, any additional mileage resulting therefore will be computed upon the charges set forth herein.
