3. OTHER CHARGES

B. Cancellation – cancellations made less than two hours before scheduled pick-up time will be charged a fee equal to the total fare.

C. Parking – tariffs listed above do not include parking. Parking fees will be charged at cost.

D. Tolls – tariffs listed above do not include tolls. Tolls for highways and/or tunnels will be charged at cost.

E. Cleaning – tariffs listed above include reasonable use. If, in the carrier's reasonable opinion, a passenger has excessively soiled the vehicle, the cost of cleaning the vehicle is the responsibility of that passenger.

F. Damage – tariffs listed above include reasonable use. Any damage to seats, windows, or any other parts of the vehicle, resulting from a passenger's action, shall be the responsibility of that passenger. The costs for repair of such damage shall be paid by the passenger.
