RULES, REGULATIONS AND CHARGES

GOVERNING

CHARTER, SIGHT-SEEING AND SPECIAL OPERATIONS BY BUS OR LIMOUSINE BETWEEN

POINTS IN THE WASHINGTON METROPOLITAN AREA TRANSIT DISTRICT

Application of Tariff: THE CHARGES HEREIN APPLY IN CONNECTION WITH THE TRANSPORTATION OF PASSENGERS AND THEIR BAGGAGE ON IRREGULAR ROUTES IN CHARTER, SIGHT-SEEING AND SPECIAL OPERATIONS BETWEEN POINTS IN THE WASHINGTON METROPOLITAN AREA TRANSIT DISTRICT.

RESTRICTED TO OPERATIONS CONDUCTED ACCORDING TO THE SAID CARRIER'S APPLICABLE TARIFF ON FILE WITH THE COMMISSION; AND

RESTRICTED AGAINST (1) TRANSPORTATION SOLELY WITHIN THE COMMONWEALTH OF VIRGINIA AND (2) ANY PASSENGER TRANSPORTATION FOR HIRE ON AN INDIVIDUAL FARE PAYING BASIS IN COMPETITION WITH ANY EXISTING, SCHEDULED, REGULAR-ROUTE PASSENGER TRANSPORTATION SERVICE PERFORMED BY, OR UNDER CONTRACT WITH, THE FEDERAL GOVERNMENT, A SIGNATORY TO THE COMPACT, A POLITICAL SUBDIVISION OF A SIGNATORY, OR THE WASHINGTON

METROPOLITAN AREA TRANSIT AUTHORITY: The Washington Metropolitan Area Transit District, referred to as the Metropolitan District, shall include: the District of Columbia; the cities of Alexandria and Falls Church of the Commonwealth of Virginia; Arlington County and Fairfax County of the Commonwealth of Virginia, the political subdivisions located within those counties, and that portion of Loudoun County, Virginia, occupied by the Washington Dulles International Airport; Montgomery County and Prince George's County of the State of Maryland, and the political subdivisions located within those counties; and all other cities now or hereafter existing in Maryland or Virginia within the geographic area bounded by the outer boundaries of the combined area of those counties, cities, and airports.

RULES AND REGULATIONS

Rule No. 1 Additional Time:

- Hourly Jobs: Additional time will be billed in 30 minute increments once minimums are met
- Transfer Jobs: After the 15 minute complimentary wait period, additional time will be billed at that vehicle's hourly rate in 30 minute increments

Rule No. 2 Cancellation Policy:

- Sedans, SUVs: 2 hours prior to reservation pick up time.
- Mini Coaches & Sprinter: 24 Hours prior to reservation pick up time.
- Motor Coach: 1 week prior to reservation pick up
- Trips cancelled inside the specified policy above will be billed at the full fare

Rule No. 3 Tolls, parking, Fees

- The rates above do not include bridge, ferry, tunnel, highway tolls, entrance fees, or parking charges. These charges will be billed as incurred.

Rule No. 4 Charges and Fees

- The payment of all charges and fees shall be the responsibility of the person or organization chartering, and carrier reserves the right to collect such charges in advance
- Any federal, state, or local taxes applicable at the time service is rendered, will be added to the final charge

Rule No. 5

Accidents and Delays

- Carrier shall not be liable for delays, interruptions or accidents due to conditions over which carrier has no control, including weather, road conditions, or acts of God

Rule No. 6

Number of Passengers

- Carrier will not accept for transportation passengers in excess of the seating capacity of the vehicle.
