RULES , REGULATIONS AND CHARGES FOR CHARTER, SIGHTSEEING AND
AIRPORT TRANSFERS BETWEEN POINTS IN THE WASHINGTON DC METRO AREA
TRANSIT DISTRICT

General Rules and Regulations:

1. **Equipment:** Charges named herein are based on vehicle being furnished of sufficient seating capacity to accommodate the chartering party.
2. **Liability of delays:** Carrier will not be liable for any delays caused by accidents, breakdowns, bad road conditions, inclement weather and other conditions beyond its control.
3. **Cancellations policy:** Cancellation received within 14 days of beginning date of service will result in forfeiture of the total cost of the charter.
4. **Conduct of passengers:** Carrier reserves the right to refuse to transport a person or persons under the influence of alcohol and drugs or whose conduct is such to make him objectionable to the safe operation of the vehicle.
5. **Charges:** all Charges are based on a whole hour increment, tolls and parking fees are not included in our prices.
