WMATC GENERAL TARIFF NO. 1 - RULES, REGULATIONS, AND CHARGES FOR RESERVED TRANSPORTATION SERVICES WITHIN THE WASHINGTON METROPOLITAN AREA TRANSIT COMMISSION'S JURISDICTION.

DATE ISSUED: January 18, 2018

EFFECTIVE DATE: January 25, 2018

General Rules and Regulations:

1. Equipment: Charges named herein are based on the vehicle being furnished of sufficient seating capacity to accommodate the chartering party.
2. Cancellation policy: All deposits are nonrefundable upon booking. Reservations that are cancelled fourteen (14) days or more prior to the departure date, will be allowed to transfer their deposit to another reservation that must take place within thirty (30) days of the originally scheduled departure date.
3. Charges: Charges named herein are hourly charges. Tolls and parking fees are not included in these hourly charges. These charges are valid for all areas within the WMATC jurisdiction.
4. Conduct of passengers: Carrier reserves the right to refuse to transport a person or persons whose conduct is such that it would hinder the safe operation of the vehicle, for others or the chauffeur.
