The rates or charges herein apply to:

The transportation of passengers over irregular routes and schedules between points in Montgomery and Prince George counties in Maryland and, District of Columbia .Also included are Arlington county, Fairfax county and Dulles International Airport in the Commonwealth of Virginia .

Note: *Mileage calculation for trips outside the Capital Beltway begin from client's pick up point to final destination*

RESTRICTED TO: Vehicles having a seating capacity of no more than 15 passengers included the driver.

II. SERVICE DESCRIPTION AND RATES

SAVED ACCESS LLC will charge the following rates (Van trip rate is double for Wheelchair):

Van trip inside the Capital Beltway	\$45 one way; \$80 round trip
Van trip outside Beltway	\$45 +\$1.25 per loaded mile
Van trip outside Beltway Round trip	\$65 +\$1.25 per loaded mile
Cancellation within 24hr of trip	\$25
Wait time after 15 mins grace period	\$20 for 30 mins intervals
Escort Services (request @booking)	\$20/hrs. 3hrs minimum time
After Hours Extreme weather rates:	\$10 per one way trip (additional)

After hours rates are based on trips booked before and after scheduled office hours. Before 6am and after 6pm Monday to Friday and anytime on weekends and federal holidays.

III. PAYMENT METHODS

Payments must be in form of visa/Master Card .Personal checks may be accepted with proper identification at the carrier's discretion with client's understanding that a fee of \$35 will be charged for any returned check due to insufficient funds.

A5% surcharge of the total amount due will be assessed for delinquent payments in excess of 30 days.
