- No Show/Cancellation: Charged to client at a flat rate of \$70. Cancellation must be called in 3hours before scheduled appointment pick up time.
- Tolls and parking: Charges will be added to rates specified above
- Any passenger route in excess of 15 miles in any one direction, whether pick up or drop off will incur additional service charge of \$2 per mile.
- Additional Stop: \$25 for each additional stop
- Additional Passengers: \$15 per additional passenger (4 or more)
