APPLICATION OF TARIFF

Fares and charges named in this tariff are stated in gross (commissionable terms; and cover only ground transportation of passengers and their baggage, as provided in Carrier's Operating Authority in transportation operations. Rates and charges provided in this tariff, for services as ordered, shall be prepaid or paid by established accounts within 30 days of service. Charges for services in addition to the services ordered and previously prepaid shall be paid within 24 hours of presentation of invoice or transportation bill to the debtor.

The transportation of passengers over irregular routes on an irregular schedule, throughout the Metropolitan District Commission's jurisdiction.

📌 RULES AND REGULATIONS:

- **Luggage**

Two Pieces of Luggage per person, not to exceed Seventy pounds each. Carrier will not be liable for loss or damage to luggage or contents thereof unless associated by lack of care of the Carrier Flammable or harmful liquids will not be transported.

- **Non-Discrimination**

Carrier will not refuse service to anyone because of race, creed, sex, or national origin.

- **Cancellation Fees**

Carrier reserves the right to charge a cancellation fee in the event that the request for services is cancelled with less than twenty-four hours' notice from the time the service is scheduled to commence Cancellation with less than twenty-four hours' notice will be charged the full amount of the chartered services.

- **Refunds**

To receive a full refund, cancellation of requested service must be received, at minimum, twenty. four hours prior to scheduled pick-up time

- **Car Damage and Clean up Fee**

The customer will be charged the actual cost or a minimum of \$50.00 for repair damage or cleaning the vehicle caused by the passenger's intentional acts or negligence, or where special cleaning beyond the carrier's normal procedures are required because of the passenger's intentional acts or negligence.

- **Objectionable Persons**

The driver of the vehicle has the right to refuse transportation services to any person(s) who is/are considered intoxicated, unruly, or believed to be under the influence of illegal drugs.

- **Seat Belts**

All passengers will be required to fasten the seat belts provided while the vehicle is in motion, Carrier reserves the right to refuse service to anyone who cannot, or will not, wear a seat belt.

- **Rule No**

- Smoking

Smoking is Prohibited in all Carrier vehicles.

- Liability

The Carrier will not be liable for the delays or cancellations cause by acts of God, public enemy terrorism, authority of law, quarantine, riots, strikes, accidents, breakdowns, bad road conditions, storm and any or other conditions beyond its control. Carrier does not guarantee onetime arrival or departure from any point at a specified time; however, the carrier will strive to maintain the schedule submitted by the agent or employee, over indicated routes, but the same are not guaranteed. If any or the adverse conditions make it in the opinion of the carrier, inadvisable to operate the equipment over any point en route, including departure and arrival points, the carrier will not be held responsible for damages for any reason(s) whatsoever.

Animals will not be carried unless they are service dogs performing assistance for the handicapped.
