- No show fee of \$60 will be charged after 20 minutes past contract start time + 20% gratuity.
- To receive a full refund, cancellation of requested services must be received at the minimum 24 hours prior to scheduled pick up time.

All rates are exclusive of chauffeur gratuity as indicated (20%), and fuel surcharge (5%), toll charges, parking fees. Gratuity and fuel surcharge fees are mandatory.
