2. Other Charges

- Cleaning charge: If, in the carrier's reasonable opinion, any passenger soils the vehicle as to render it in an unpresentable condition for further use, a cleaning charge of \$300 will be assessed against that passenger or passengers.

- Damage charge: Vehicles are carefully inspected by carrier prior to each trip. Any damage to seats, windows, or other equipment or parts of the vehicle which is caused by any passenger or passengers shall be the responsibility of that passenger or passengers and the costs to carrier for the repairs of such damages shall be paid by the passenger(s).
- Tolls, fees and special charges: The charges herein do not include bridge, ferry, tunnel, or highway tolls, entrance fees or charges for special licenses or permits. An additional charge will be assessed for the actual cost of such tolls, fees or special charges.

RULES AND REGULATIONS
