

4. CANCELLATION, NO-SHOW, AND ORDER MODIFICATION RULES:

To avoid cancellation charges, orders must be cancelled two hours before reservation time. A no-show will be charged after 30 minutes, and cancellation charges will apply. No-show and cancellations charges will be charged 100% of the reservation total.

5. AIRPORT PICKUP PRICING AND PROCEDURES:

N&N Transportation Services LLC will meet passengers inside the arrival terminal, unless otherwise instructed. If meeting passenger inside there will be a meet and greet \$15 additional charge and parking charges will apply. To avoid parking charges, passengers can request an outside pickup.
