These definitions are used only for Aafamily LLC General Tariff:-

Carrier:- The term “carrier” refers on this document to Aafamily LLC

Company:- The term “company” refers on this document to Aafamily LLC

Customers:- The term “customers” refers on this document to passengers who get ride services from Aafamily LLC

Vehicle:- The term “vehicle” refers on this document to the specific vehicle of the company that has been given operating permit by WMATC to conduct business in the Washington Metropolitan Area

Terms and Conditions: The term “terms and conditions” refers on this document to the rules of performances set by the carrier that the carrier and customers should follow while conducting business

Rate:- The term “rate” refers on this document to the amount in USD that customers are charged for getting ride services from the carrier

Jurisdiction:- The term “Jurisdiction” refers on this document to the scope of locations that WMATC considered them under the Washington Metropolitan Area.

WMATC:- The term “WMATC” refers on this document to Washington Metropolitan Area Transit Commission

Commission:- The term “commission” refers on this document for Washington Metropolitan Area Transit Commission

Terms and Conditions

- The carrier is required to obey the terms and conditions set by WMATC to conduct a For-hire passenger carrier business by motor vehicles in the Washington Metropolitan Area
- The carrier will let customers know rates of respective ride services before or during the pickup time if the pickup or destination point is in the jurisdiction
- The carrier will let customers know new rate updates if customers added or changed destination or pickup point or if customers want to cancel requested ride services
- The carrier and customers are required to approach each other respectfully
- If customers decide to cancel prearranged trips, they are responsible to notify the carrier 1 hour a head if the trip is scheduled on the same day and 4 hours a head if the trip is scheduled before 12 hours of the pickup time.
- The carrier is responsible to notify the customers as soon as possible if any inconvenience occurs during or before pickup times of prearranged trips.
- Customers are responsible to compensate appropriate values of carrier's property if they damage, spill out, get dirty etc of the vehicle or any property of the carrier
- Cancellation fees for prearranged trips cancelled by customers within an hour before departure of carrier to pickup location for trips scheduled on the same day will be 25% of the actual rate of the respective trip.
- Cancellation fees for prearranged trips cancelled by customers within 2 hours before departure of carrier to pickup location for trips scheduled before 12 hours will be 50% of the actual rate of the respective trip.
- Cancellation fees for prearranged trips cancelled by customers after departure of carrier to pickup location & before drop off at the destination for all trips will be 100% of the actual rate of the respective trip.
- Waiting time during pickup due to delay of customers will be free of charge for the first 10 minutes for all prearranged trips.
- Waiting time during pickup due to delay of customers will add \$5 to the actual rate, at every 15 minutes for all prearranged trips that starts after 10 minutes of the pickup time.
- If customers request to change their destination before onboarding the rate will be adjusted to the new destination rate.
- If customers request to add stop or destination points the rate will increase by \$10 per mile on top of the initial rate.
- If customers request to cancel one or more stop or destination points the rate will be adjusted to the remaining destination/s
- If customers request to change stop or destination points after onboarding, the rate will be adjusted as addition of stop or destination points
- If customers want to pay on Square App using credit cards or by Cash App transfer, the payments will add transaction fees of 3.5% and 3%, respectively.
