Section I

Application of Tariff

THE CHARGES HEREIN APPLY IN CONNECTION WITH THE TRANSPORTATION OF PASSENGERS AND THEIR BAGGAGE IN SIGHTSEEING AND CHARTER OPERATION BY DOUBLE DECKER BUS AND TROLLEY:

BETWEEN POINTS IN THE WASHINGTON METROPOLITAN AREA TRANSIT DISTRICT.

RESTRICTED TO OPERATIONS CONDUCTED ACCORDING TO THE CARRIER'S APPLICABLE TARIFF ON FILE WITH THE COMMISSION AND:

RESTRICTED AGAINST (1) TRANSPORTATION SOLEY WITHIN THE COMMONWEALTH OF VIRGINIA AND (2) ANY PASSENGER TRANSPORTATION FOR HIRE ON AN INDIVIDUAL FAR PAYING BASIS IN COMPETITION WITH ANY EXISTING, SCHEDULED, REGULAR-ROUTE PASSENGER TRANSPORTATION SERVICE PERFORMED BY, OR UNDER CONTRACT WITH, THE FEDERAL GOVERNMENT, A SIGNATORY TO THE COMPACT, A POLITICAL SUBDIVISION OF A SIGNATORY, OR THE WASHINGTON METROPOLITAN AREA TRANSIT AUTHORITY.

SIGHTSEEING OPERATIONS WILL BE CONDUCTED OVER VARIOUS ROUTES BUT WILL GENERALLY OPERATE IN LOOPS COMMENCING AND ENDING AT L'ENFANT PLAZA, OR THE WASHINGTON MONUMENT WITH STOPS AT HISTORICAL AND TOURIST ATTRACTIONS AND LOCATIONS THROUGHOUT NORTHWEST AND SOUTHWEST D.C. AND ARLINGTON VIRGINIA.

Section II

General Rules and Regulations

RULE NO. 1 AVAILABILITY OF EQUIPMENT: When charter operations are performed, charges named herein are based on vehicle being furnished of sufficient seating capacity to accommodate the chartering party. All charges, unless accepted in advanced, are subject to the carrier's ability to supply equipment.

RULE NO. 2 NUMBER OF PASSENGERS: Carriers reserves the right to refuse for transportation passengers in excess of the seating capacity for the vehicle.

RULE NO. 3 BAGGAGE: Baggage will not be checked and will be the responsibility of the passenger in sightseeing operations or the chartering party. Personal baggage, musical equipment, athletic equipment, and other paraphernalia necessary for the purpose of the trip shall be transported without additional charge but shall be limited to the space available.

RULE NO. 4 SPECIAL CHARGES: To the charges named herein will be added any federal, local, or other taxes in effect at the time the service is rendered. When in charter service, rates are exclusive of parking, entrance fees, and tolls.

RULE NO. 5 PAYMENT OF CHARGES: For charter operations all charges will be assessed against and/or collected from the person or organization in charge of the group chartering the vehicle. Carrier reserves the right to collect all charges before departing from point of origin.

RULE NO. 6 CONDUCT OF PASSENGERS: Carrier reserves the right to refuse to transport a person under the influence of alcohol or drugs, or whose conduct creates a disruption or poses a hazard to the other passengers or driver. Any damage to a vehicle caused by a passenger shall be the responsibility of the passenger and/or charter party.

Section II (cont.)

RULE NO. 7 ACCIDENTS AND DELAYS: The carrier will not be liable for delays caused by accidents, breakdowns, bad road conditions, snowstorms, or other conditions beyond carrier's control and when such conditions prevail, does not guarantee to arrive at or depart from any point at any specific time. If conditions over which carrier has no control, such as weather, road conditions, or Act of God, make it in the opinion of the carrier, inadvisable to operate, either from point of origin or at any point in route, the carrier shall not be liable therefore, or caused to be held for damage of any reason.

RULE NO. 8 STOPOVER AND IDLE TIME: When in charter operations, and upon request of the charter party, stopovers are made, or time is consumed in boarding, the applicable hourly rate for the vehicle ordered will be charged.

RULE NO. 9 REPORT CHARGE: When a vehicle is ordered for charter and not used, there will be a minimum charge of 50% of the total price for the charter.

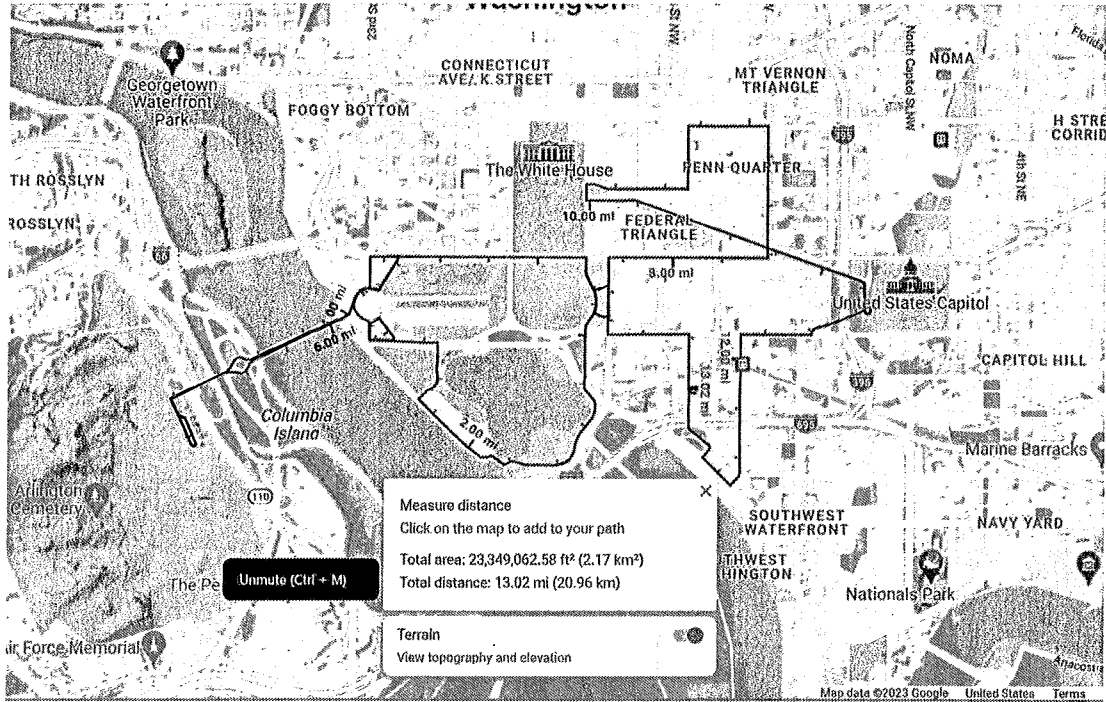
