This matter is before the Commission on the response of Sheba Network, LLC, trading as Sheba, (respondent or applicant) to Order No. 15,838, served September 4, 2015, in Case No. MP-2014-111; Order No. 15,883 served October 6, 2015, in Case No. MP-2015-172; and an application filed October 27, 2015, requesting voluntary termination of Certificate No. 2368.

In Case No. MP-2014-111, respondent's Certificate of Authority was revoked on May 15, 2015, in Order No. 15,591, for respondent's willful failure to comply with Regulation No. 58-14(a) and Order No. 14,969. A request for reconsideration by respondent was denied in Order No. 15,753, served July 21, 2015, but in light of respondent's belated compliance, this Commission reopened the proceeding on its own initiative and reinstated Certificate No. 2368. Order No. 15,753 placed respondent on probation for one year and, because the reconsideration request informed the Commission that respondent had changed its legal name, Order No. 15,753 also directed respondent to file a name change application within 14 days. Respondent failed to file the name change application. Accordingly, Order No. 15,838, served September 4, 2015, directed respondent to show cause within 30 days why the Commission should not suspend or revoke Certificate No. 2368 for respondent's failure to comply with Order No. 15,753.

In the meantime, Certificate No. 2368 was automatically suspended on August 4, 2015, for respondent's willful failure to comply with the insurance requirements specified in Regulation No. 58. Order No. 15,883, served October 6, 2015, in Case No. MP-2015-172, noted that Certificate No. 2368 would be subject to revocation if respondent failed to file the necessary insurance endorsement(s) and pay a \$100 late fee within 30 days. Respondent has yet to file the necessary insurance endorsements but on October 27, 2015, respondent paid the \$100 late fee online.

During the course of these proceedings, applicant submitted two applications requesting voluntary termination of Certificate No. 2368, but each was denied because applicant owed fees or forfeitures to the Commission and was subsequently not in good standing.<sup>1</sup> On October 27, 2015, applicant filed the pending third application requesting voluntary termination of Certificate No. 2368.

The Executive Director may approve an application for voluntary termination under Regulation No. 54-08, provided the applicant is in good standing with the Commission.<sup>2</sup> Inasmuch as no fees or reports are currently due from applicant, and applicant therefore is in good standing, the application shall be granted.

THEREFORE, IT IS ORDERED:

1. That Certificate of Authority No. 2368 is hereby terminated, effective this date.
2. That within 30 days from the date of this order applicant shall:
  - a. remove from applicant's vehicle(s) the identification placed thereon pursuant to Commission Regulation No. 61;
  - b. file a notarized affidavit and supporting photograph(s) with the Commission verifying compliance with the preceding requirement; and
  - c. surrender Certificate No. 2368 to the Commission.
3. That ordering paragraph No. 5 of Order No. 15,753 is hereby rescinded and Case Nos. MP-2014-111 and MP-2015-172 are hereby terminated.
