By application filed August 21, 2017, WMATC Carrier No. 1637 requests that the name on its certificate of authority be changed from Bovex's Limousine Services, Inc., to Bovex Limousine Worldwide Inc. This is the second such application.¹

Under Regulation No. 54-08, the Executive Director may approve an application to change a legal name not involving a transfer of authority. Legal name applications shall include proof of legal change.

Applicant is a Virginia corporation. In support of its application, applicant has submitted a copy of the certificate of amendment issued by the Virginia State Corporation Commission certifying applicant's change of name from Bovex's Limousine Services, Inc., to Bovex Limousine Worldwide Inc., and a certificate of good standing issued by the Virginia State Corporation Commission in applicant's new corporate name.

Accordingly, the application shall be granted.

THEREFORE, IT IS ORDERED:

1. That upon applicant's timely compliance with the requirements of this order, Certificate of Authority No. 1637 shall be reissued to Bovex Limousine Worldwide Inc., 4601 Pinecrest Office Park Drive, Alexandria, VA 22312-1442.

2. That applicant may not transport passengers for hire between points in the Metropolitan District pursuant to this order unless and until applicant's certificate of authority has been reissued as amended in accordance with this order.

3. That applicant is hereby directed to present its revenue vehicle(s) for inspection and file the following documents within the

180-day maximum permitted in Commission Regulation No. 66: (a) evidence of insurance pursuant to Commission Regulation No. 58; (b) an original and four copies of a tariff or tariffs in accordance with Commission Regulation No. 55; (c) a vehicle list stating the year, make, model, serial number, fleet number, license plate number (with jurisdiction) and seating capacity of each vehicle to be used in revenue operations; (d) a copy of the for-hire vehicle registration card, and a lease as required by Commission Regulation No. 62 if applicant is not the registered owner, for each vehicle to be used in revenue operations; and (e) proof of current safety inspection of said vehicle(s) by or on behalf of the United States Department of Transportation, the State of Maryland, the District of Columbia, or the Commonwealth of Virginia.

4. That the approval of amendment herein shall be void and the application shall stand denied upon applicant's failure to timely satisfy the conditions of reissuance prescribed herein.
