By application filed October 12, 2018, applicant requests that the legal name appearing on Certificate No. 1229 be changed from Miljen Transportation, LLC, to Milton Transportation LLC.

Under Regulation No. 54-08, the Executive Director may approve an application to change a legal name not involving a transfer of authority. Legal name applications shall include proof of legal change.

Applicant is a Maryland limited liability company. In support of its application, applicant has submitted proof that articles of amendment changing applicant's legal name from Miljen Transportation, LLC, to Milton Transportation LLC have been filed with and accepted by the Maryland Department of Assessments and Taxation.

Accordingly, the application shall be granted.

THEREFORE, IT IS ORDERED:

1. That upon applicant's timely compliance with the requirements of this order, Certificate of Authority No. 1229 shall be reissued to Milton Transportation LLC, 5406 Tilden Road, Bladensburg, MD 20710-1552.

2. That applicant may not transport passengers for hire between points in the Metropolitan District pursuant to this order unless and until applicant's certificate of authority has been reissued as amended in accordance with this order.

3. That applicant is hereby directed to file the following documents and present its revenue vehicle(s) for inspection within the 180-day maximum permitted in Commission Regulation No. 66: (a) evidence of insurance pursuant to Commission Regulation No. 58; (b) an original and four copies of a tariff or tariffs in accordance with Commission Regulation No. 55; (c) a vehicle list stating the year, make, model, serial number, fleet number, license plate number (with jurisdiction) and seating capacity of each vehicle to be used in revenue operations; (d) a copy of the for-hire vehicle registration

card, and a lease as required by Commission Regulation No. 62 if applicant is not the registered owner, for each vehicle to be used in revenue operations; (e) proof of current safety inspection of said vehicle(s) by or on behalf of the United States Department of Transportation, the State of Maryland, the District of Columbia, or the Commonwealth of Virginia; and (f) the original WMATC Certificate of Authority No. 1229 issued August 16, 2006.

4. That the approval of amendment herein shall be void and the application shall stand denied upon applicant's failure to timely satisfy the conditions of reissuance prescribed herein.
