By application filed October 31, 2018, Freedom II Limousine Services Limited Liability Company seeks to add a seating capacity restriction to Certificate of Authority No. 2183.

The restriction would confine applicant's operations to vehicles with a seating capacity of less than 16 persons, including the driver, thereby reducing from \$5 million to \$1.5 million applicant's minimum insurance obligation under Commission Regulation No. 58.

Under Regulation No. 54-08, the Executive Director may approve an application to add a seating capacity restriction to a certificate of authority. In support of its application, applicant has submitted evidence that its fleet consists solely of vehicles seating 15 or fewer persons, including the driver. Accordingly, the application shall be approved.

THEREFORE, IT IS ORDERED:

1. That upon applicant's timely compliance with the requirements of this order, Certificate of Authority No. 2183 shall be reissued, as amended consistent with this order, to Freedom II Limousine Services Limited Liability Company, 2409 Naylor Road, S.E., Washington, DC 20020-4534.

2. That applicant may not transport passengers for hire between points in the Metropolitan District pursuant to this order unless and until Certificate of Authority No. 2183 has been reissued in accordance with the preceding paragraph.

3. That applicant is hereby directed to file the following documents and present its revenue vehicle(s) for inspection within the 180-day maximum permitted in Commission Regulation No. 66: (a) evidence of insurance pursuant to Commission Regulation No. 58; (b) an original and four copies of a tariff or tariffs in accordance with Commission Regulation No. 55; (c) a vehicle list stating the year, make, model, serial number, fleet number, license plate number (with jurisdiction) and seating capacity of each vehicle to be used in

revenue operations; (d) a copy of the for-hire vehicle registration card, and a lease as required by Commission Regulation No. 62 if applicant is not the registered owner, for each vehicle to be used in revenue operations; (e) proof of current safety inspection of said vehicle(s) by or on behalf of the United States Department of Transportation, the State of Maryland, the District of Columbia, or the Commonwealth of Virginia; and (f) the existing Certificate of Authority No. 2183 reissued September 1, 2017.

4. That the approval of amendment herein shall be void and the application shall stand denied upon applicant's failure to timely satisfy the conditions of reissuance prescribed herein.
