On February 4, 1973, the Washington Metropolitan Area Transit Authority completed takeover of the regular route operations of the four major bus lines in the area (D. C. Transit System, Inc., Washington, Virginia and Maryland Coach Company, Alexandria, Barcroft and Washington Transit Company, and WMA Transit Company).
