Certificate No. 3077 was automatically suspended on May 1, 2021, pursuant to Regulation Nos. 60-03 and 67-04 as a result of respondent's failure to file a 2021 annual report, pay its \$175 annual fee for 2021, and pay \$300 in associated late fees incurred under Regulation No. 67-03(a)&(b) on or before April 30, 2021. Order No. 19,351, served May 3, 2021, in Case No. MP-2021-057 gave respondent 30 days in accordance with Regulation Nos. 60-04(a) and 67-06(a) to file the annual report and pay the fees or face revocation of Certificate No. 3077. Respondent did not respond.

While Case No. MP-2021-057 was pending, Certificate No. 3077 was further suspended at 12:01 a.m. on May 5, 2021, by operation of Regulation No. 58-12, and a \$100 late insurance fee became due and payable under Regulation No. 67-03(c), when the \$5 million primary WMATC Insurance Endorsement on file for respondent terminated without replacement. Order No. 19,359, served May 5, 2021, in Case No. MP-2021-070 gave respondent 30 days in accordance with Regulation No. 58-12(b) to file the necessary WMATC Endorsement(s) and pay the \$100 late insurance fee or face revocation of Certificate No. 3077. Respondent filed the necessary insurance endorsement(s) later in the day on May 5, 2021, but has yet to pay the \$100 late fee.

Accordingly, Certificate No. 3077 shall be revoked pursuant to Regulation Nos. 58-15(a), 60-05(a), and 67-09(a).

## THEREFORE, IT IS ORDERED:

- 1. That Certificate of Authority No. 3077 is hereby revoked.
- 2. That respondent's 2021 annual report and \$575 in unpaid fees shall remain due in accordance with Regulation Nos. 60 and 67.

- 3. That within 30 days from the date of this order respondent shall:
  - a. remove from respondent's vehicle(s) the identification placed thereon pursuant to Commission Regulation No. 61;
  - b. file a notarized affidavit and supporting photograph(s) with the Commission verifying compliance with the preceding requirement; and
  - c. surrender Certificate No. 3077 to the Commission.
