Capital Area Transportation & Executive Services, LLC, has filed an application to add the trade name "Cates, LLC." to Certificate No. 3293.

Under Commission Regulation No. 54-08, the Executive Director may approve an application to change a trade name. A trade name application by an applicant with a principal place of business in the District of Columbia, Maryland, or Virginia shall include proof of trade name registration in the jurisdiction where applicant's principal place of business is located.

Applicant's principal place of business is located in Maryland. The application is supported by proof of registration of the new trade name with the Maryland Department of Assessments and Taxation. Accordingly, the application shall be conditionally approved.

THEREFORE, IT IS ORDERED:

1. That upon applicant's timely compliance with the requirements of this order, Certificate of Authority No. 3293 shall be reissued to Capital Area Transportation & Executive Services, LLC, trading as Cates, LLC., 11728 Folkstone Court, Waldorf, Maryland 20602-4105.

2. That applicant may not transport passengers for hire between points in the Metropolitan District pursuant to this order unless and until a certificate of authority has been reissued in accordance with the preceding paragraph.

3. That applicant is hereby directed to present its revenue vehicle(s) for inspection and file the following documents within the 180-day maximum permitted in Commission Regulation No. 66: (a) evidence of insurance pursuant to Commission Regulation No. 58; (b) an original and four copies of a tariff or tariffs in accordance with Commission Regulation No. 55; (c) a vehicle list stating the year, make, model, serial number, fleet number, license plate number (with jurisdiction) and seating capacity of each vehicle to be used in revenue operations; (d) a copy of the for-hire vehicle registration card, and a lease as

required by Commission Regulation No. 62 if applicant is not the registered owner, for each vehicle to be used in revenue operations; (e) proof of current safety inspection of said vehicle(s) by or on behalf of the United States Department of Transportation, the State of Maryland, the District of Columbia, or the Commonwealth of Virginia; and (f) the original Certificate No. 3293 issued May 30, 2019.

4. That the grant of authority herein shall be void and the application shall stand denied upon applicant's failure to timely satisfy the conditions of reissuance prescribed herein.
