Case No. MP-2022-026

Certificate No. 3378 was automatically suspended on May 11, 2022, by operation of Regulation No. 58-12 when the \$1.5 million primary WMATC Insurance Endorsement on file for respondent terminated without replacement. Order No. 19,782, served June 2, 2022, in Case No. MP-2022-026 gave respondent 30 days in accordance with Regulation No. 58-12(b) to file the necessary WMATC Endorsement(s) and pay a \$100 late insurance fee under Regulation No. 67-03(c) or face revocation of Certificate No. 3378.¹ Respondent has yet to file an acceptable insurance endorsement and pay the \$100 late fee.

In the meantime, Certificate No. 3378 was further suspended on May 1, 2022, pursuant to Regulation Nos. 60-03 and 67-04 as a result of respondent's failure to file a 2022 annual report, pay its \$175 annual fee for 2022, and pay \$300 in associated late fees incurred under Regulation No. 67-03(a)&(b) on or before April 30, 2022. Order No. 19,756, served May 2, 2022, in Case No. MP-2022-020 noted that Certificate No. 3378 would be subject to revocation if respondent failed to file the report and pay the fees within 30 days. Respondent has yet to respond.

Accordingly, Certificate No. 3378 shall be revoked pursuant to Regulation Nos. 58-15(a), 60-05(a), and 67-09(a).

THEREFORE, IT IS ORDERED:

1. That Certificate of Authority No. 3378 is hereby revoked.

¹ Order No. 19,782 erroneously stated respondent's insurance endorsement expired June 2, 2022. The endorsement was canceled on April 11, 2022, effective May 11, 2022.

2. That respondent's 2022 annual report and \$575 in unpaid fees shall remain due in accordance with Regulation Nos. 60 and 67.

3. That within 30 days from the date of this order respondent shall:

- a. remove from respondent's vehicle(s) the identification placed thereon pursuant to Commission Regulation No. 61;
- b. file a notarized affidavit and supporting photograph(s) with the Commission verifying compliance with the preceding requirement; and
- c. surrender Certificate No. 3378 to the Commission.
