This matter is before the Commission on applicant's request for an extension of time to comply with Commission Order No. 19,929, served October 11, 2022, in Case No. AP-2022-129, and on applicant's application to add the trade name "Valley View Transportation" to an unissued certificate of authority.

Order No. 19,929 conditionally granted Certificate of Authority No. 3577 and stipulated that applicant would have the full 180 days available under Commission Regulation No. 66, or until April 10, 2023, under Rule No. 7-01, to satisfy the conditions of the grant. On April 7, 2023, applicant requested an extension of the deadline.

Regulation No. 66-01 states: "Except as provided in Regulation No. 66-02, the time for complying with the conditions of a grant of authority shall not be extended beyond 180 days from the date of the grant. A conditional grant of authority shall be void on the 181st day following the date of the grant if full compliance has not been achieved at that time." Regulation No. 66-02 states: "Upon timely request for an extension of the 180-day deadline in Regulation No. 66-01, the Commission's Executive Director may grant a maximum extension of 31 days." The request having been timely filed, an extension of 31 days shall be granted, and applicant shall have until May 11, 2023, to satisfy the conditions of the grant stipulated in Order No. 19,929.

Under Regulation No. 54-08, the Executive Director may approve an application to change a trade name. A trade name application by an applicant with a principal place of business in the District of Columbia, Maryland, or Virginia shall include proof of trade name registration in the jurisdiction where applicant's principal place of business is located.

Applicant's principal place of business is located in Maryland. The application is supported by proof of registration of the new trade

name with the Maryland Department of Assessments and Taxation. Accordingly, the application shall be conditionally approved.

THEREFORE, IT IS ORDERED: That upon applicant's satisfaction of the conditions of the grant stipulated in Order No. 19,929 on or before May 11, 2023, Certificate of Authority No. 3577 shall be issued to Valley View Partners LLC, trading as Valley View Transportation, 4400 Stamp Road, #404A, Temple Hills, MD 20748-6730.
