By application filed April 10, 1980, David C. Pearson trading as E & H Transportation Company (Pearson) seeks a certificate of public convenience and necessity to transport passengers in special operations between Washington, D. C. and the District of Columbia Department of Corrections facility at Lorton, Va. Applicant states that he will provide an on-call door-to-door service picking up and returning passengers at their residence, concentrating in the vicinity of Georgia Avenue and Florida Avenue, N. W., and Martin Luther King Avenue and Good Hope Road, S. E.

The proposed charge for the trip is \$6 per person round-trip, service to be performed Monday through Friday in the evening and on weekends and holidays during the day, in 15-passenger vans.

The Compact, Title II, Article XII, Section 4(b) provides that an application for a certificate of public convenience and necessity may be granted ". . . after hearing held upon reasonable notice. . . ." Accordingly, a public hearing will be scheduled on the application, and Pearson will be directed to publish notice of the application in a local newspaper and post similar notice in his vehicles. Inasmuch as applicant has a public hearing on another matter scheduled for May 12, 1980, the instant application will be scheduled for hearing at the same time and there will be no additional assessment made for the hearing.

THEREFORE, IT IS ORDERED:

1. That the above-entitled proceeding is hereby scheduled for public hearing to commence at 9:30 a.m. Monday, May 12, 1980, in the Hearing Room of the Commission, Room 314, 1625 I Street, N. W., Washington, D. C. 20006.

2. That applicant is hereby directed to publish once in a newspaper of general circulation in the Metropolitan District notice of this application and hearing, in the form prescribed by the staff of the Commission, no later than Friday, April 18, 1980.


3. That applicant is hereby directed to post in each of his vehicles, conspicuously and continuously through the date of the public hearing, notice of this application and hearing in the form prescribed by the staff of the Commission no later than Friday, April 18, 1980.

4. That applicant is hereby directed to produce at the hearing affidavits of said publication and posting.

5. That any person desiring to protest shall file a protest in accordance with Commission Rule 14, or any person desiring to be heard in this matter shall so notify the Commission, in writing, no later than Friday, May 2, 1980, and shall mail a copy of said protest or notice to David C. Pearson trading as E & H Transportation Company, 7600 Georgia Avenue, N. W., #206, Washington, D. C. 20012.

6. That applicant is hereby directed to file with the Commission six copies of a projected revenue and revenue deductions statement for the proposed service, the original to be produced at the above-scheduled hearing, no later than Wednesday, May 7, 1980, and to serve a copy thereof on each party of record as of Friday, May 2, 1980.


