By application filed May 12, 1983, George's Limo Taxi, Inc., seeks authorization to conduct charter operations pursuant to WMATC Special Certificate of Public Convenience and Necessity No. 1 under a contract with NUS Corporation (an engineering consulting firm), transporting employees and persons traveling on official business between NUS facilities at 910 Clopper Road, Gaithersburg, Md., and Washington National and Dulles International Airports, and Union Station, Washington, D. C.

Order No. 2420, served May 17, 1983, generally describes the evidence submitted with the application, and that order is incorporated by reference herein. The Commission required publication of notice and the filing of an affidavit of publication. Applicant complied with these requirements and no protests to the application were received by the Commission within the time set therefor.

Commission Regulation No. 70 provides that an application of this type will be granted if it is determined that the applicant is fit, willing and able properly to perform the proposed service and to conform to the provisions of the Compact and the rules, regulations and orders of the Commission thereunder, and if it is determined that the proposed operations conform to the provisions of Regulation No. 70. The issue of whether the public convenience and necessity require such service has been determined in Case No. MP-79-04. See Order No. 2004, served June 20, 1979.


Inasmuch as the contract is for a fixed term of at least 181 days and provides for the transportation of employees pursuant to a contract with their employer, as well as persons traveling on official business, the Commission finds that this application conforms to the requirements of Commission Regulation No. 70. It is further found, based on the evidence of record as described in Order No. 2420, that applicant is fit, willing and able properly to provide the service

described above and to conform to the requirements of the Compact and the rules, regulations and orders of the Commission thereunder.

A certificate of insurance is already on file. George's Limo Taxi, Inc., is assigned WMATC Authorization No. 83, is directed to identify its vehicles in accordance with Commission Regulation No. 70-10, and is further directed to file an affidavit of compliance with that regulation within ten days from the date of service of this order. Within the ten-day time period, applicant must also file two copies of the title page for its WMATC Tariff No. 1 in accordance with Commission Regulation No. 55-04. Copies of the contract with NUS are already on file. Upon the filing of the affidavit of compliance and the tariff title page, an appropriate authorization will be issued. The authorization, however, will not include authority to serve Union Station, inasmuch as there has been no inclusion of that point in the contract for service between applicant and NUS.
