By Order No. 2956, served January 8, 1987, International Limousine Service, Inc. ("ILS"), was directed, among other things, to post notice of its application and the hearing thereon in each of its vehicles. By motion filed February 2, 1987, ILS states that such notice was not posted due to an administrative error. Therefore, ILS seeks a postponement of the public hearing and additional time to comply with the requirements of Order No. 2956. The motion will be granted.


THEREFORE, IT IS ORDERED:

1. That the public hearing in Case No. AP-86-46 scheduled for February 12, 1987, is hereby cancelled.
2. That the public hearing in Case No. AP-86-46 is hereby rescheduled to commence Tuesday, March 3, 1987, at 9:30 a.m. in the hearing room of the Commission, 1625 I Street, N.W., Room 314, Washington, D.C. 20006.
3. That the applicant shall post continuously and conspicuously in each of its vehicles through the date of public hearing, notice of this application and the hearing thereon in the form prescribed by the staff of the Commission, no later than Monday, February 9, 1987, and present at the hearing an affidavit of said posting.
4. That any person desiring to protest this application shall file a protest in accordance with Commission Rule No. 14, or any person desiring to be heard on this matter shall so notify the Commission, in writing, no later than Friday, February 20, 1987, and shall simultaneously serve a copy of such protest or notice on applicant's attorney, Jere W. Glover, Esq., 1725 K Street, N.W., Suite 308, Washington, D.C. 20006.

5. That applicant is hereby assessed \$300 pursuant to Title II, Article XII, Section 19 of the Compact and is directed to deliver said amount to the office of the Commission, 1625 I Street, N.W., Suite 316, Washington, D.C. 20006, no later than Friday, February 20, 1987.

6. That applicant is hereby directed to file with the Commission no later than Friday, February 20, 1987, the following items: (a) an equipment list specifying make, model, seating capacity, vehicle identification number, serial number, and license plate number for each vehicle to be used in WMATC operations; (b) a projection of revenues and revenue deductions to be generated by the proposed operations; and (c) a reconciliation of the year-to-date retained earnings with the operating loss for that same period.
