By application accepted for filing on May 5, 1992, pursuant to the Commission's letter ruling on applicant's preliminary motion, Clyde's Charter Bus Service, Inc., doing business as Gunther Charters (Gunther or applicant), a Maryland corporation, seeks a certificate of authority to transport passengers, together with baggage in the same vehicles as passengers, in irregular route operations between points in the Metropolitan District.

Gunther proposes to initiate operations using eight owned vehicles having a manufacturer-designed seating capacity of 43-49 passengers each. Applicant's proposed tariff contains hourly rates and transfer rates for charter bus service.

Gunther's application includes information regarding, among other things, its corporate status, facilities, vehicle maintenance arrangements, driver training practices, proposed tariff, finances, and regulatory compliance record. The application is available for inspection at the office of the Commission during its regular business hours.

In determining whether to grant or deny an application for a certificate of authority, the Compact at Title II, Article XI, Section 7 requires that the Commission determine whether an applicant is fit, willing, and able to perform the transportation properly and conform to the provisions of the Compact and the Commission's rules, regulations, and requirements and whether the transportation is consistent with the public interest. Pursuant to Commission Rule No. 6, this order and fulfillment of its requirements will provide notice of Gunther's application for a certificate of authority.


THEREFORE, IT IS ORDERED:

1. That Clyde's Charter Bus Service, Inc., doing business as Gunther Charters, shall publish once in a newspaper of general circulation in the Metropolitan District, notice of this application in the form prescribed by the staff of the Commission, no later than Friday, May 15, 1992.
2. That Clyde's Charter Bus Service, Inc., Trading as Gunther Charters, shall file with the Commission, no later than Friday, June 5, 1992, an original and four copies of an affidavit that notice has been published as required in the preceding paragraph.
3. That any person wanting to protest the issuance of a certificate of authority to Clyde's Charter Bus Service, Inc., doing business as Gunther Charters, shall do so in accordance with

Commission Rule No. 13 and Regulation No. 54-04(a), and any person wanting to comment on this matter, other than by protest, shall do so in writing, in accordance with Regulation No. 54-04(a), by filing such protest or comment at the office of the Commission, 1828 L Street, N.W., Suite 703, Washington, DC 20036-5104, no later than Friday, June 5, 1992, and shall simultaneously serve a copy of such protest or comment on applicant's representative, Jeremy Kahn, Esquire, 1726 M Street, N.W., Suite 702, Washington, DC 20036.

4. That any person seeking a formal oral hearing in this matter shall request one in accordance with Commission Regulation No. 54-04(b) no later than Friday, June 5, 1992, and shall simultaneously serve a copy of such request on applicant's representative, Jeremy Kahn, Esquire, 1726 M Street, N.W., Suite 702, Washington, DC 20036.
